New Soil Management Rules Will Impact Brownfield Redevelopment

With the on-set of Regulation 406/19 respecting On-site and Excess Soil Management in Ontario, new rules around the planning, management, documentation, and tracking of excess soil are now in place for any project involving the excavation. With these requirements, there are also some relaxing of soil processing activities that previously required the use of a regulatory approval.

Although the new rules are applicable in Ontario, the soil management activities will prove useful in all brownfield situations when executed; however, the rules need to be fully understood and employed at the start of the project planning. Brownfields typically have contaminated soils that are treated or removed from the site, but the redevelopment activities often generated other soil volumes that will be excess to the project once excavated. These excess soils now require appropriate management.

This presentation will discuss some of the new requirements and how they impact the redevelopment process for Brownfields, as well as discussing a recent case study on early management activities.
